# EMBARGO ON RECORDS RELATING TO POSSIBLE AUSTRALIAN DEFENCE FORCE/DEFENCE PERSONNEL EXPOSURE TO TOXIC CHEMICALS AND SIMILAR MATERIALS

#### **Purpose**

1. To advise that the Directorate of Records Management Policy (RMP) is imposing a Defence-wide disposal embargo on records relating to possible Australian Defence Force (ADF)/Defence personnel exposure to toxic chemicals and similar materials.

#### **Background**

- 2. In response to legal proceedings, RMP is imposing a Defence-wide disposal embargo on records relating to possible ADF/Defence personnel exposure to toxic chemicals and similar materials. This new embargo will subsume the extant *Exposure to Beryllium* embargo.
- 3. The disposal embargo suspends the National Archives of Australia's (NAA) permission to destroy any relevant records that could otherwise be legally destroyed under current records authorities issued by the NAA and designates any relevant records as not suitable for destruction through normal administrative practice.

#### Length of freeze

4. The records embargo is effective from 21 August 2013 and will be reviewed 12 months from date of release. The embargo will remain in place until lifted by RMP.

#### **Records affected**

- 5. The disposal embargo covers all records relating to possible ADF/Defence personnel exposure to toxic chemicals and similar materials listed in annex A. The embargo extends to all Defence records held in all areas of Defence, other agencies and organisations including state and local offices.
- 6. This disposal embargo will subsume the extant *Exposure to Beryllium* embargo, as Beryllium is included in the chemicals/materials listed in annex A.
- 7. 
# Implications of embargo on sentencing

8. The disposal embargo means that, although the records may continue to be sentenced, no disposal action of any kind may be undertaken. Records must not be transferred to the NAA or otherwise disposed of.
